Call to Order

Pat McKee spoke on IRS 2010 “Targeted governance of non-profits”. Form 990 organizational return of 2010.
Importance of running 501C according to IRS rules.

Spoke of excesses that benefit some for example

– where someone on board, a major contributor profits from dealings with non-profit.

Sound fashion

– corporate laws provides some guidance.

Good governance

– “American Alliance of Museums” AAM

– book “Best Practices”; AGB – book on best practices;

IRS has some publications that they want to see in well run organizations.

3 Basic structures:

1) Raise money; 2) set policy / mission; 3) hire CEO;

Best not to have CEO carry out mission or policy

For example, separation of policy making and administrative duties

Question: What is to be asked of board members? What is their role in organization?

In IRS 990, “Enron” and SOX – things to consider:

1. Document and retention policy – Criminalize destruction policy

5 years - IRS documents

2 years – employment documents

Optional – destroy

Never – Incorporation, 501C,

Email policy

2. Conflict of Interest policy

3. Ethical standards policy

4. Strategic planning retreat

10 yr., 5 yr. planning

5. “Whistle blower” policy
